

## **GENERAL CONDITIONS**

1. The owner, operator or mover of a heavy vehicle, load, object, or structure in respect to which the letter of authorization is granted is nevertheless responsible for all damages that may be caused to the road, by reason of driving, operating, or moving of any such heavy vehicle load, object or structure.
2. The applicant agrees to indemnify and save harmless the Rural Municipality of Antelope Park No. 322 and the Rural Municipality of Milton No. 292 from any action, claim, damage, or loss whatsoever, arising from operation carried out under this letter of authorization.
3. The issuing of this letter does not relieve the holder thereof from the requirement of any legislation whether federal, provincial, or municipal.
4. No movement of overweight vehicles will be permitted during adverse road and/or weather conditions.
5. The letter of authorization is only valid for the roads that are under the jurisdiction of the Rural Municipality of Antelope Park No. 322 and the Rural Municipality of Milton No. 292.
6. It is the responsibility of the letter holder to ensure that the vehicle or object moving as adequate insurance coverage and is properly licensed to transport the load specified on the letter of authorization.
7. The user of any road or structure may be restricted at any time.
8. This letter of authorization must be carried in the vehicle at all times.
9. When passing vehicles on municipal roads, slow down to 60 km/hr.
